- 6. V-18-278 / 312 Ferguson Street NE [CPNO] Applicant seeks a variance from the zoning regulation to 1) reduce the required front yard setback from 30 feet to 23.6 feet and 2) reduce the required south side yard setback from 7 feet to 1.5 feet. L5PBA motion to support, passed 5-0-0
- 7. V-18-291 / 415 Sterling Street NE [CPNO] Applicant seeks a variance from the zoning regulation to reduce the north required side yard setback from 7 feet to 3 feet [changed to 2.35 feet]. L5PBA motion to defer, passed 5-0-0.

V-18-295 / 361 Oakdale Road NE [CPNO] Applicant seeks a variance from the zoning regulation to 1) increase the maximum size of an accessory structure from 30 percent of the heated square footage of the main structure to 39 percent of the main structure, 2) reduce the required southern side yard setback from 7 feet to 1.4 feet (with alley credit) to erect a new accessory structure.
